In order for a dog to be registered with the ASDCA, it must meet the Anatolian Shepherd Dog breed standard set by the AKC and ASDCA. Please see the following web site for the Anatolian Shepherd Dog breed standard http://www.akc.org/breeds/anatolian_shepherd_dog/.

NAMING GUIDELINES

The ASDCA will follow the AKC's guidelines for naming of dogs.

- Name choices are limited to (36) thirty-six characters. Spaces between words, apostrophes and hyphens are counted.
- All letters in a dog's name are limited to the standard English alphabet. Diacritical markings (accent grave, accent acute, umlaut, etc.) are not printed on the Registration Certificate in a dog's name. When Registration Certificates are printed, all letters are capitalized.
- Words and phrases that may not be included in a dog's name:
 - Champion, champ, sieger or any other AKC title or show term, either spelled out or abbreviated;
 - Obscenities and words derogatory to any race, nationality or transliterations of such words;
 - Kennel(s), male, stud, bitch, dam and female;
 - Breed Names alone; and
 - There are no restrictions on arabic (1,2,3) cardinal (one, two, three) or ordinal (first, second, third) numbers that are spelled out.

ASDCA Registration of Imported Anatolian Shepherd Dogs

The following is required for ASDCA Registration of imported Anatolian Shepherd Dogs.

- 1) Be at least 18 months of age or older to be registered
- 2) Signed, notarized pedigree from the Breeder of record
- 3) Proof of importation/shipping documents (such as the Bill of Lading)
- 4) Health Certification from the Country of Origin (necessary to ship a dog)
- 5) The dog must be positively and permanently identified through a microchip prior to being registered
- 6) Photo Documentation. Color prints must be a minimum of 4x6 with a maximum of 10 feet distance from the camera to the dog. The requested registered names of the dog must be printed on the back of each photograph. There are 4 required pictures
 - a) Straight on head shot
 - b) Front Full Body
 - c) Side Full Body (must contain a reference point for the height such as a yard stick)
 - d) Rear Full Body

Video and/or physical inspection will be required. Contact the ASDCA Registrar for current video requirements and/or specifics for physical inspection.

Additional requirements for Kangal Registration:

- 1) **In additional to all of the above requirements, dogs currently registered as Kangals must furnish the ASDCA with their original registration certificate.**

ASDCA Registration of United States Born Anatolian Shepherd Dogs

The following are required for ASDCA Registration of Individual Anatolian Shepherd Dogs born in the United States or its possessions or territories.

- 1) A Certified Three-Generation Pedigree from an ASDCA recognized registry (AKC, UKC, ASDW)
- 2) Photo Documentation. Color prints must be a minimum of 4x6 with a maximum of 10 feet distance from the camera to the dog. The requested registered names of the dog must be printed on the back of each photograph. There are 4 required pictures
 - a) Straight on head shot
 - b) Front Full Body
 - c) Side Full Body (must contain a reference point for the height such as a yard stick)
 - d) Rear Full Body

Video and/or physical inspection may be required.

Additional requirements for Kangal Registration:

- 1) **In additional to all of the above requirements, dogs currently registered as Kangals must furnish the ASDCA with their original registration certificate.**
